#### CHAIRPERSON'S CORNER by June Ezold

Another year has passed since we were last in touch with most of you. This is to bring you somewhat up to date about your tribe and to notify you of another election.

Our petition submitted to BIA for review is still number five on the BIA "Active ready, for consideration" list. The petition process is extremely slow and it may take another 4 or 5 years before the petition is reviewed and acted upon. Until we are officially acknowledged we remain ineligible for BIA services. Brothertown Nation, Incorporation operates through the generous contributions of individuals and the volunteer labor of tribal members, their families and friends.

This past year the Brothertown Nation, Inc. has been active in receiving donations for its land fund and for administration services. We have been investigating the feasibility of conducting and American Indian Walkathon as a fund raiser for the Tribe and contacted Calumet County government officials to ascertain what type of assistance might be available to the Tribe and its members.

This past year the Brothertown Tribe was active in Wisconsin's Sesquicentennial celebrations, assisted numerous Brothertown youth in securing higher educational grants from the state of Wisconsin, nominated the Fox River for inclusion in the American River Heritage Program, established a tribal web site on the Internet and secured approval of a historical marker identifying the site of the original Brothertown reservation in the state of Wisconsin. There will be a dedication planned for the event this year. We have been collaborating with the Brothertown Union Cemetery Association to help maintain and improve the cemetery grounds. The majority of the people buried at the cemetery are Brothertown Indians and spouses. We will also be responsible for maintaining the marker after it is installed.

We presently have approximately 2400 Brothertown members, half of whom are under the age of 18.

Of paramount importance is securing a land base where the Brothertown people can build a tribal headquarters, have tribal meetings, ceremonies and to actively plan for its economic development.

We propose to have a survey to be sent to each Brothertown household as to their interest in relocating their families to the Brothertown tribes original reservation in Brothertown Township, Calumet County; assess the Tribal members as to the interest in being recognized, what are the most important items, in their minds, as to what should come after recognition—education, purchase of land, economic development, etc. This is in the planning stage and the results will be needed for the future. We are also going to review our Constitution and by-laws to be ready when we become federally recognized. This we must do.

In this report you will have information from the Pow wow and crafts committee; eastern tribe from June 11-19; information about new membership cards; information for election of your representatives; and a calendar for the year.

The Council want to thank each of you for your funding donations and help that has been given this past year. We all can be proud of what has transpired for the Tribe in this past year. We all are working towards a common goal, to be federally recognized and to be self-sufficient.. We make a terrific team. Thank you all. Keep up the good work. We will be having another raffle this year. More later. We hope to see you at some of our meetings.

#### Exercise Your Right To Vote!

The election of the Nominating Committee for your Tribal Council was held at the February General meeting. Mark Schreiner, Dick Welch, and Jim Ottery were elected. The offices that will be open for election are Vice-Chairman and two Council positions. At the March meeting, nominations were accepted from the floor, but no one was nominated. Elections will be held at the May, 1999, Tribal General meeting. If you wish to exercise your right to vote, you can vote at the May 1999 Brothertown General Assembly held at North Fond du Lac, Wisconsin Community Center. If you are unable to attend this meeting, please see instructions below.

#### Absentee Voting Information

In order to request an absentee ballot, you must send a SIGNED WRITTEN request for an absentee ballot along with a stamped, self-addressed envelope to:

In order to vote, each member must be listed on the current Brothertown Tribal roll, be 18 years of age or older, and each member must request a single ballot. DO NOT send all family member requests in one envelope. If you know your enrollment number, please include this with your request. Once received, Caroline will check your enrollment and send you an absentee ballot. Return the ballot to Caroline in a SEALED ENVELOPE inside the envelope you mail it in (so the mailing envelope can be opened to reveal the sealed envelope which contains your ballot). Caroline must receive your ballot postmarked no later than May 10, 1999. When your ballot is received, it will be added to the ballot box which will be opened at the May 15th General Assembly meeting. DO NOT SIGN the ballot or the envelope holding the ballot.





#### **Chairperson Report**

In the process of recognition we have been approached by investors over these many years since we sent in the petition. We met with them, listened to what they had to offer and weighed everything. So far we haven't taken any of the bait handed out. At the present time we have another committee to met with another group of investors and they have had one meeting to date. A reporter was at our last meeting and one of the committee members mademore information available to him and it made several of the newspapers in Wisconsin. The articles said we are working with a group of investors that are interested in helping with recognition and to start a casino. The word casino stood out but good. The newspapers picked up on the word casino and has caused quite a ripple in Wisconsin. I haven't heard from any other state as yet. We cannot even talk about a casino or gaming until we are recognized by the federal government and who knows when that will be. Also the Tribe has to vote if that is wanted, and also get land, and also get a compact with the

Governor. As I said, the word casino put up a red flag for the news media. We will most certainly let everyone know what goes on with your tribe.

Information is in the newsletter about ID card, enrollment and pow wow and crafts information. Also the picnic coming up in July.







Chairperson's Report Migizi Manitou Equay

Greetings from your Tribal Council. I will try to make this report to the point but not too long.

A lively discussion was held at our July 17 picnic. After all the discussion died down the idea came across that our communication system was not adequate to inform members of all that is transpiring in regard to the Tribe. We also learned from another part of the discussion we do not allow anyone to be at our Council meetings. In order to be heard at a Council meeting, one must be put on the agenda. It can be done by contacting a Council member before the meeting. Otherwise you may attend but must be on the agenda to be heard. This has been our procedure. We need more volunteers to take an active interest in the workings and duties of your Tribe. Attending meetings would help to fill in that so called "gap."

It seems a few are working at a fast pace trying to accomplish recognition; to raise funds to assist in the administrative programs; to help keep all informed; to put forth a positive image of our Tribe to the political entity and the general public; to spread our story and to have outsiders know who we are as well as knowing ourselves.

Any help any of the members out there can assist in accomplishing this job will be more than appreciated. We need you. If the aim is wanting to have your Tribe active and to be run efficiently and to get the message out, we need more members working towards that goal and attending meetings and workshops.

After much hard work and thought, trial and error we were notified we are being awarded a grant the middle of September or the first of October by Admin-

istration for Native Americans (ANA). This will enable us to advertise for a tribal planner, rent an office and to give our arts and crafts a boost and to get more assistance and volunteers to help make this a lucrative business. We need your help.

We are also making plans for a Walkathon next summer starting at Stockbridge and ending in Brothertown with a celebration at the end of the six miles of walking. We are looking for sponsors, (funds and media) and to have help in the planning and participation. We need your help.

Any questions you might have feel free to give one of us a call. Let us hear from you if you are interested in our plan.

We are now number four on the BAR list of "Active, ready for consideration." We are still moving forward to that time of recognition, as much as we can.

A raffle is to held to raise funds to assist us in the administration of your tribe. The drawing is to be October 16, 1999 at the Homecoming event at Fond du Lac Park Lakeside Pavilion. We are offering \$100, \$50, \$25, dream catcher, embroidered picture, rocking horse and afghan for the raffle. The tickets are \$1.00 each or 6 for \$5.00. # BROTHERTOWN INDIAN HERITAGE WALK DESCRIPTION


The Brothertown Nation, Inc. proposes to sponsor an annual "American Indian Heritage Walk" designed as a 10 kilometer walkathon to benefit the Brothertown Tribe of Wisconsin. The goals of the event would be to 1) increase public awareness of the history and culture of the Brothertown Indian Tribe of Wisconsin; 2) generate critically needed general operating support for the tribe through this fundraising event; and 3) increase public awareness of the history and culture of other Wisconsin Indian Tribes through the distribution of information and through performances of American Indian artists at a thank you party immediately after the event. The first year objective is to garner the participation of 150 walkers with a fundraising goal of netting \$15,000 that will support Brothertown tribal operations. The long-term objective is to secure a growing unrestricted revenue stream to support operations and assist the tribe in its social and economic development and activities.

A thank you party/cultural celebration will occur at the conclusion of the walkathon and will incorporate elements of a traditional pow wow: performance of American Indian dances and songs, and inter-tribal participation. Through the event the larger non-Indian community can learn about Wisconsin Indian Tribes while participants contribute through the pledges they have collected from their family and friends. The success of the event itself will be directly dependent on the active participation and cooperation of Brothertown tribal members who will serve as walkers, event volunteers, and outreach advocates.

The walkathon would begin the village of Stockbridge and conclude in Brothertown, the site of the tribe's original reservation in Wisconsin. This is a path that was heavily traveled by Brothertowners as they interacted with neighboring Stockbridgers. On the day of the event, shuttle busses will transport walkers from population centers such as Fond du Lac or Appleton to the starting site of the walk, and back to those locations at the conclusion of the thank you party. This shuttle service will reintroduce a Brothertown "jitney" which historically transported tribal members from the former reservation to population centers.

An integral part of the walkathon will be the informa-

tion dissemination activity that will occur at the thank you party. All Wisconsin Indian tribes will be invited to staff booths that will provide information on their respective histories and cultures. As a result of the Brothertown Tribe's exhaustive effort to research and document its existence as a tribe for its federal acknowledgement petition, the tribe possesses an impressive archive of historical and cultural information. Selected artifacts and documents will be on display to increase the general public's knowledge of the Brothertown Tribe, its members, its history and its contributions to the State of Wisconsin. Other Wisconsin tribes will be invited to participate in the event and distribute information on their histories and cultures. American Indian artists and dancers will perform at the post -walk thank you party. Finally, the larger non-Indian community will be invited to participate as volunteers, walk sponsors and walkers.



#### Brothertown Trip-June 11-20, 1999 By Deborah Pickering

On June 11, forty-nine travelers, most of whom are Brothertowners, left Wisconsin for historic sites in New York and Connecticut. We ranged in age from the teens to eighty-something, but most of us were middle-aged. Thirteen of us were men. Several family groups made the trip, but some people came along. The journey was enlightening and emotional for all. In both states we were welcomed by representatives of the government, the tribes, and occasionally the press. Our leaders, who spent more than a year planning the trip, were Dennis Gramentz, Alicia Johnson, and Jessica Kramer.

After two long days of driving, sometimes through heavy rain, we arrived at Hamilton College in Clinton, located in central New York (also known as Leatherstocking Country after the series by James Fenimore Cooper). After breakfast at the college, we attended services at the Congregational United Church of Christ in Deansboro. The church members had prepared a special service for us, including songs by Samson Occum and shaped-note or Sacred Harp music, a choral folk tradition that originated in Colonial and English singing schools in the 18<sup>th</sup> and 19<sup>th</sup> centuries.

After the service we visited historic sites in the area. Our ancestors left New York for Wisconsin early in the 19<sup>th</sup> century; what remains in central New York are a few grave sites and homes as well as the original land-granting documents at Hamilton College. The original Brothertown lands are in a beautiful valley sur-

rounded by hills, a two mile wide rectangle of farm land between Clinton and Oriskany Falls. We visited the farm house where David and Hannah garret Fowler lived – Lawrence Ames lives there now. The Fowler graves, along with those of Samson Occum and others, are in a wooded lot on that same farm. We also visited the Dick Family burying ground, the school/meeting house built in 1810 (now a private residence), and a third cemetery with 22 marked, but unidentified, graves. Only the Dice graveyard has been maintained, the other two are located in wooded areas on farms. Before our arrival, the local townspeople cut away underbrush and, in the case of the Fowler/Occum gravesite, they also tied orange flags near the graves so we could find them. These visits were emotional for many of us; some took rocks and dirt and left flowers or tobacco.

Dinner was equally overwhelming. We were welcomed by the entire community at a buffet at Joan's Old Museum in Deansboro, where we ate and conversed with townspeople, listened to speeches, and presented gifts. Attending were local residents who planned for our arrival: Russell Blackwood, a retired Hamilton College philosophy professor, Phillipa Brown, and Dorothy McConnell, historian for the town of Marshall. All have studied and/or written about the Brothertown history in New York. The next day, June 14, we had the opportunity for several hours to see the original documents at the Hamilton College library.

At noon, we left for Stockbridge, Massachusetts, driving through the Hudson River Valley to see Berkshires. Although we were only in Stockbridge for a few hours, we visited the library and two other sites. By this time, Cynthia Griggs of Collinsville, Connecticut, a Brothertown historian, had joined the group. She stayed with us until we left for home, providing information about families and locations. On June 15, after spending the night in Hartford, Connecticut, we went to Farmington, where we visited the Day-Lewis Museum, a repository of local Indian history, located near the site of travel routes and meeting places thousands of years old. Peg Yung, a Farmington resident and local historian, was our guide through the sites. We also saw Farmington Meadows, where Tunxis Indians once farmed, and burial grounds, including Riverside Cemetery, which features a marker erected in 1840 for an Indian burial ground. In Farmington, as elsewhere, we were welcomed and met by representatives of state and local governments as well as Native Americans.

We had lunch at the First Church of Christ (Congregational), built in 1652. In the church hall, members of the congregation served us a meal of Indian food – succotash, cornbread, and a casserole of turkey, wild rice, and cranberries. After lunch, the mayor as well as others spoke, and we presented gifts.

That afternoon, most people visited rock shelters and a soapstone quarry in Canton; others went to the People's Woods on the Farmington River. Later, we left for Mystic, Connecticut on Long Island Sound.

We spent most of June 16 at the Pequot Museum, located on the reservation near Mystic. This passage from the brochure does justice to the museum, which opened as recently as August, 1998. "This dazzling 308,000-square-foot facility traces the rich cultural heritage and tumultuous history of the Pequot Tribe from prehistoric times to the present through a fascinating blend of life-like displays and state-of-the-art computer and multimedia technology." It would take several days to see everything, but most of us were impressed with the 22,000 foot square village and moved by one of the 13 original films, "The Witness."


The entire day was very emotional. When we first arrived and assembled in The Gathering Place, a dome-shaped glass enclosed area, we were met by some members of the Pequot Tribe. One woman, after greeting those whose faces and names were familiar to her, said "We've been waiting for you to come home. Needless to say, it was a tearful reunion. We also had lunch that day with the elders of the Mashantucket Pequot Tribe where we were welcomed and each given a small gift.

After dinner at Abbott's Lobster in the Rough, a rustic seafood restaurant on the shore, many of us visited the Foxwoods Resort Casino, the source of the Mashantucket Tribe's prosperity. The huge complex employs 11,000; visitors per day average 40,000. the most dramatic tribal touch is the Rainmaker statue at the center of the complex of buildings. The 12 foot plastic statue of an Indian hunter shoots a laser-beam arrow into the air once an hour to invoke the Great Spirit. The response is the sound of thunder, and then artificial showers rain into the base of a fountain.

The next day, June 12 we went to Uncasville and Montville on the Mohegan reservation. We visited the Mohegan church, which is being restored, the Tantaquidgeon Indian Museum, Fort Shantok State Park, the Mohegans 17<sup>th</sup> century settling place and burial grounds, and the Mohegan Sun, a casino. The later was built to resemble a Native American long house. the interior design, as well as the architecture, reflects and embodies the Mohegan culture. We were each given a booklet, Mohegan Sun: The Secret Guide, which explains the symbols, logos, and names throughout the casino. the four entrances represent the four directions, each correlating with a season. Each entrance is decorated to honor and symbolize a season. The casino is, in effect, a museum rich with symbols.

That evening, June 17, we began the trip home. After spending the night at Casantota, New York, we drove to Niagara Falls where we spent three hours on our own sight-seeing. The evening of June 18 we drove to London, Ontario to spend the night. Then, after a long drive, we were back in Wisconsin on June 19. some of us left the group in Milwaukee, but most went to Fond du Lac on June 20 to visit more familiar with Brothertown graveyards and to share one last meal together.

Each of us had a different experience on this trip, but all would probably agree that discovering distant relatives and walking the land our ancestors walked gave us a profound sense of connection to other members of the tribe and to our roots. We learned so much and deepened our understanding of who we are and what our ancestors survived.



#### **Brothertown Historical Marker**

Background: Through the efforts of the Brothertown Indian Community Council, the State Historical Society of Wisconsin approved on February 16, 1999 the placement of an historical marker recognizing the Brothertown Indians. On July 21, 1999 the Calumet County Highway Department in cooperation with the State Department of Transportation installed the large 54" X 72" Wisconsin historical marker entitled "THE BROTHERTOWN INDIANS OF WISCONSIN." The marker has been placed on state highway wayside (No 4) at the intersection of State Highways 55 and 151 in Calumet County on the northern boundary of the original Wisconsin Brothertown property. the marker has a great site on a crossover road with a separate parking lot. The site has a great view of Lake Winnebago. When you look to the southeast from the marker site you can see the Brothertown Cemetery.

Public Safety Concerns: This historical marker site cannot accommodate a large crowd without concerns for public safety. When visiting the Brothertown marker,







#### Report from the ANA Project Director

As many of you know, a grant was submitted to the Administration for Native Americans' Social and Economic Development Program in May, 1999. In August we received unofficial word that the tribe's nonprofit corporation, the Brothertown Nation, Inc., would be receiving a one-year \$77,321 grant for the Brothertown Indian Resource, Craft and Housing Development Project ("BIRCH" Project). The three objectives of this project are to: 1) perform a comprehensive analysis to determine the housing needs of tribal members; 2) provide a centralized operating facility near the largest concentration of Brothertown Indians; and 3) expand and increase revenue from the tribe's craft development and sales effort. The grant supports the salary of a full-time Tribal Planner/Fundraiser, a 1/3 time Project Administrator, provides money for the purchase of craft supplies and covers the cost of operating an office in Fond du Lac for a 12-month period. The project received final approval from the ANA in mid-September and started officially on September 28, 1999. The tribe has pledged \$39,607 in in-kind contributions as it's match for ANA funds.

The overall goals of the project are to increase support for the Brothertown Tribe and develop its capacity to administer tribal programs. The office provides a location for craft development activity, for a monthly Council of Elders gathering, for volunteers to work on federal acknowledgment activity, and for volunteers to plan fundraising activity that will enable the office to become self-supporting. Specific goals for the craft committee are increasing the number of craft participants by 30 percent, and increasing the net revenue from craft sales by 40 percent over the next twelve months. Specific goals for the housing needs analysis are to: survey all tribal households to determine their housing needs; complete a study on using the Low Income Housing Tax Credit Program for developing housing for tribal members; and produce a report on opportunities to partner with other housing nonprofits to create housing for tribal members. Mark Baldwin, ANA Project Consultant, will be working with the Tribal Planner/Fundraiser on the housing and fundraising objectives of the grant.

The original application asked for funding for a two-

year period, and we will reapply to the ANA to continue these efforts when the project period expires in September 2000. A Fond du Lac office became operational on November 1, 1999. The Brothertown Tribal Archives were moved from the Adams House to the Fond du Lac office in early November. The address for the office is 493 Fond du Lac Avenue, Fond du Lac, WI 54935. The telephone number is (920) 929-9964 and the fax number is (920) 921-8124. We encourage everyone to come by and see the office which is located across from the Fond du Lac County Fairground.

After reviewing over 200 resumes, and a series of telephone and in-person interviews, we are pleased to report that we have hired Shawn Woodin as the project Tribal Planner/Fundraiser. He worked as a small business advisor in the U.S. Peace Corps in Kenya collaborating with local government on development projects. He advised individual entrepreneurs in management techniques and taught business management to groups of skilled artisans. For the past two years he has worked as a Program Coordinator for a job mentoring program at Heartland Community College and as a Small Business Consultant at Illinois State University where he consulted on management issues, created business plans and feasibility studies. Woodin has a B.S. degree in Business Management from Binghamton University-State University of New York. In December he will complete his M.S. degree in Political Science with a concentration in Community and Economic Development from Illinois State University in Normal, IL. He is in the process of relocating with his wife, Chero, to Fond du Lac and he will begin work on December 1, 1999.

One of the first things Mr. Woodin will be focusing on is drafting a questionnaire that will be sent to all Brothertown head-of-households to obtain demographic information for use in planning activity. A major focus of the questionnaire will be the housing needs of tribal members. We urge all of you to complete this questionnaire and return it as soon as possible so we can determine what your needs are and how the tribe can best address them. He will also be working closely with the Craft Committee to strategize ways to increase volunteer participation and income from craft sales. He will

also conduct a business plan to determine the feasibility of converting the craft initiative into a tribal business. Another focus of the Tribal Planner/Fundraiser will be to write a grant application to secure funds to implement programs that meet the needs of tribal members and build the tribe's governmental capacity.

Therefore, we have a tremendous need for office volunteers, crat volunteers, and fundraising volunteers. A project that everyone can participate in is a fundraising walkathon scheduled for July 16, 2000, the day after the annual tribal picnic. See the accompanying article (American Indian Heritage Walk 2000) that provides details on what we hope will be an annual fundraising event. #### AMERICAN INDIAN HERITAGE WALK 2000

The Brothertown Nation. Inc. is proposing to hold an American Indian Heritage Walk on Sunday, July 16, 2000 to help raise funds to continue the operation of the Fond du Lac office and support general tribal operations. The Walk will also benefit the Union Cemetery Association to assist them in their efforts to maintain the grounds of the cemetery where so many Brothertown Indians are buried.

The Walk is scheduled to begin at the Firemens' Park in Stockbridge and end at the Maltby homestead on Lakeshore Drive in Brothertown near the Union Cemetery. The 10-kilometer walkathon will be followed by a thank-you party and cultural celebration featuring American Indian singers, dancers and performers. We are currently soliciting corporations and foundations to underwrite the cost of producing the walkathon and encouraging Brothertown tribal members, spouses, family and friends to sign up as walkers or event volunteers.

We are happy to report that at the Brothertown Homecoming 50 people signed up to be walkers and 13 people signed on as volunteers. Fox Valley residents will also be encouraged to participate in the Walk to learn more about the Brothertown Tribe, other Wisconsin tribes and expand the base of people making contributions to support the Brothertowns' acknowledgement effort. This is an event that everyone can participate in—as a walker, event volunteer, as a sponsor of a walker, or an event promoter.

We are excited that WBAY-TV in Green Bay, Wisconsin has agreed to serve as the event's media sponsor. This means it will interview Brothertown representatives on its noon public affairs program prior to the Walk. It will also create public service announcements promoting walker and volunteer participation and broadcast them in the five to six weeks prior to the Walk. This is a tremendous endorsement of the Walk as the station takes on few new promotional events. They tend to continue to promote events they have supported in the past and we hope to forge a strong partnership with WBAY-TV as we work to make the Walk an annual fundraising event for the Brothertown Indians of Wisconsin.

We will also be pursuing in-kind donations such as prizes for the top walkers, printing services, T-shirts, and snacks and beverages for walkers. #### International Folk Fair

From Friday, November 19, 1999 to Sunday, November 21, 1999, the International Folk Fair was held at State Fair Park, near Milwaukee, WI. Martha Stephenson and Heather Bauer conducted two demonstration workshops on talking feathers. Martha showed people how to make the basic talking feather and Heather showed them how to decorate it with beading using the peyote stitch. We also spoke a little about talking feathers.

Many people hang their talking feathers in homes or cars. Their beauty and rarity signify the importance or status within the owner's tribe. At Council and other important meetings in many northeastern Native American communities, at talking feather is what controls the conversation. It is not the feather itself that speaks, but rather the person who has the feather is the only one who's allowed to speak. No one may interrupt. After the first person has had their say, the talking feather is

passed on from one person to the next as an indication of who's turn it is to speak. This way seems more fair to me because everyone gets a chance to voice their opinion without being cut off.

The following examples of beading talking feathers have been made using Peyote or Gourd stitch. Each glass bead is attached one at a time and is interwoven into the beads on each side. Traditionally talking feathers are made with an eagle feather and are decorated with leather and perhaps more feathers, beads, etc. As with everything in our lives, we make it beautiful.
