CHAIRPERSON'S CORNER

What a winter we had and everyone else. I think we will have snow until the 4th of July.

I want to thank all the members who have given of their time, talent and money to assist the Tribe in becoming recognized. It is most appreciated. We couldn't continue without you. I can't possibly name you all because there are so many, but you know who you are. Thank you.

We are scheduled to receive assistance from a grant that was written in October to help setting up our constitution and also with strategic planning. We are interviewing for a Tribal Planner to assist us for the next 18 months. We are still waiting for the ANA decision as to what month it will start.

We were picked by VISIONARIES, a non-profit organization that records about organizations that have a story to tell. This is to be done this fall, but will appear on PBS in 2002. Will tell more later.

We still need a lot of help for the Walkathon, volunteers for the office, helping with the enrollment process, help with the Elders meetings, help with mailings, public relations, crafts, sunshine committee, etc. You name it we need help.

In order for us to have a strong case for recognition, we are going to need better attendance at our meetings. We have our petition with our history, but we must also prove we are serious about recognition and continuing as a tribe. We have 2,500 enrolled members and must have 15 members in attendance, according to our by-laws. A good many times we just squeak by with 17 or 18 in attendance. Of course, we do have 9 members on the Council so that leaves only 6 more members to be in attendance. There are over 400 heads of household members in the Fox River Valley area so we should have better attendance. We are asking you to set aside the 3rd Saturday of 6 months out of the year, to attend very important meetings. The schedule is February, March and May at the North Fond du Lac Senior Building; July is the annual picnic at Calumet County Park; August is in Gresham at the American Legion Hall and October is Homecoming at the Fond du Lac Lakeside Park Pavilion. See you there!! You know it's time to set our sights on goals to be accomplished. You want to have new leadership, so lets attend meetings so you know what is going on.

Maureen Betz and John Ebert have started getting the Archives in order for them to be put on microfilm. We have a grant that was written to accomplish this huge project. They are both connected with the Fond du Lac Historical Society. We could not use volunteers for this portion of the project.

ENROLLMENT REPORT

The enrollment of members who managed to get their application in by December 31, 2000 is in process. It is a slow and arduous task. Each application has to be reviewed, make certain all the documents are included, if they can be traced back to the 1839 or 1901 rolls, recorded, write the notification letter, then entered into the computer. Doesn't sound like much does it. But when you have between 250 and 300 applications and everything is not included, it does take time. So please be patient. You will be notified in the future.

Remember if you change your name or address you must let us know or you will be lost to the tribe.

We are still accepting applications, but they will be set aside until the December 31st applications are complete of course, you realize any applications received now will be put on hold for enrollment until the rolls are reopened. We are asking that you enclose ALL documents including all birth certificates to which you trace your ancestry. We usually have the court claims from 1839 or 1901 rolls, but you must furnish all other documents. Also, please do not send more than 4 applications in one envelope. We have received boxes with 25 to 100 applications in one bunch.

I have served my church, the Oneida United Methodist Church, for my entire life as Treasurer and Administrative Board Chairman. I am retired and would enjoy the opportunity to serve the Brothertown Indians of Wisconsin. Thank you for considering me for Tribal Council.

Steve Cottrell

I am running for Tribal Council. My ancestor is my paternal grandmother Inez DeGroat Cottrell. Since enrolling into the Brothertown Indians of Wisconsin I have become interested in the historical and contemporary life of the tribe. I am the print shop manager for a large engineering firm in Green Bay. I have gained experience in the necessary steps for any project development including environmental and architectural. I have served my church in many volunteer roles for my entire adult life. My desire to run for Council is based largely on the fact that my wife and sons are members of the Oneida Tribe of Indians of Wisconsin. I have seen first hand the good and bad that stems from a successful tribal government. This is an unique experience that I can bring to the Brothertown Indians of Wisconsin Council. HOW TO VOTE

The first way is to come to the meeting on May 19th, 1:30 p.m. at the North Fond du Lac Senior Building, 280 Garfield Street, North Fond du Lac.

If you are unable to come you may request an absentee ballot by sending a written request to Dawn Krantz at 188 Rose Avenue, Fond du Lac, WI 54935. You must also include a self-addressed stamped envelope. One written request per envelope. Dawn will then send you a ballot in the self-addressed envelope. Put your ballot in an envelope with no markings on it. Then place it in another envelope and send it to Dawn.

ANOTHER ROAD TO RECOGNITION

The Brothertown Indian Nation of Wisconsin is at a critical juncture in its effort to secure federal recognition. As many of you know, the tribe's federal acknowledgement petition was submitted in February 1996. The petition is currently number four on the Federal Acknowledgement Board's list for activation. However, it may take another several years before the actual review begins. The review process itself takes a minimum of two years and the decision is subject to appeal and further delays. Therefore, the Brothertown Tribal Council has voted to pursue a second avenue of achieving federal recognition. This is through the court system by filing a land claim in New York. If we can demonstrate that our ancestral homeland was sold in violation of the Non-Trade and Intercourse Act, the court will accord federal acknowledgment and award a modest financial settlement. Our intention is not to reoccupy the land, or disturb the current landowners. We will continue to seek recognition through the petitioning

process, but we will also pursue this other road to recognition. In order to initiate this effort, we need to secure legal representation and we need your financial support. All Brothertown head-of-households will be receiving a letter explaining in more detail the effort we are about to undertake and how we need your participation and assistance. Please read this letter carefully and do not hesitate to contact any of you Council members if you have any questions or concerns. With your help we hope to speed up the federal acknowledgment process and restore the Brothertown Indian Tribe of Wisconsin to its rightful place as a recognized Indian Nation.

The Brothertown Tribal Council is aware of the group calling themselves the "New York Brothertown Indian Nation" and has issued the following statement.

"The Brothertown Indian Nation of Wisconsin has no affiliation with the group calling themselves the New York Brothertown Indian Nation. The Brothertown Nation of Wisconsin is investigating the pending land claim case in Oneida and Madison Counties and its consequences on the tribe's federal

acknowledgment effort. Members of the Brothertown Indian Tribal Council are discussing this matter and will take appropriate action to protect the rights of the Brothertown Indian Nation of Wisconsin and its members.”

The executive Committee of the Tribal Council held a conference call with Greg Smith, Esq. on Monday, March 5th to get an update on the situation. A decision was made to initiate a search for legal representation to protect the tribe’s rights in this matter. We will try to keep you updated as events unfold.

MORE BROTHERTOWN HISTORY

How many know the story of the Brothertown elm box? This is an oval decorated box that was returned to the Mohegan tribe from the Peabody and Essex Museum in Salem, MS. The box is made of elm bark and was made by a Wisconsin Brothertown Indian and sent “home” to their Mohegan relative. It is an artifact that tells the story of the Brothertown migration from the east to New York and finally to Wisconsin. It represents one of the few surviving written records in an ancient design language of East Woodland Indians.

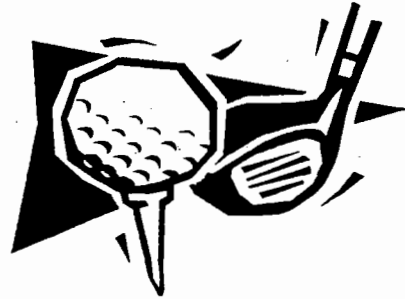
The design on the box is a trail covered by dots, representing the people traveling and leaves depicting each tribe. It also has a curving line representing a sun trail, which represents the Indians following the path followed westward. There is a spiral on the lid with seven pipes representing the seven tribes joined in a circle.

CHAIRPERSON'S CORNER

The Council wishes to thank all the persons that had their name put on the ballot for the election. Remember, next year is another year so please continue to show an interest and attend the future meetings and put your name on the ballot again.

I am sorry to announce that Mr. Richard (Dick) Welch has handed in his resignation. He was a member of the Board of Commissioners and he felt that he could not attend many of the future meetings due to his work schedule. We are most sorry for that decision and we want to publicly thank him for the time spent to help the tribe. He is still willing to give talks about the Tribe to schools.

Please read the reports given by the committee chairmen in the newsletter so you can keep up with the events of the tribe for the future.

Any questions you might have in regard to the tribe, feel free to call on any of the Council members or officers and if they do not know the answer, they will find someone who will help you.

The Council is going to start working on the Constitution with the help of Greg Smith, and they will be setting up meetings with members to get their input as to what the members feel should be in the constitution and by-laws. This is going to take some time, you realize. It cannot be done overnight. The last time we made amendments it took over 2 years. You see, we will be getting ideas from the meetings to be held in Washington or Oregon, Minnesota, Michigan, New York and Wisconsin bringing the ideas back, putting together the constitution and by-laws, mail them out to members to get the approval and then try to work something out that is in agreement to all. This is one of the items for which the grant was written.

We also will be working with the Tribal Planner in regard to the second section of the grant for the strategic planning and working on the constitution. The crafts and housing weren't included this time.

Here is another episode in the New York Brothertown Nation filing for land in the Oneida Land Claim.

The headline in the Syracuse Newspaper reads as of May 23, "Judge adds Brothertown tribe to Oneida suit."

In the Day newspaper of Connecticut they reported "Indian Group from Norwich joins New York lawsuit."

Excerpts of the report. "A federal judge this week, agreed to allow the Brothertown Indian Nation of New

York, whose leaders live, in southeastern Connecticut, to intervene in the 27-year old lawsuit brought by several Oneida tribes. The Oneidas' opposed the Brothertowns' request to join the lawsuit, claiming it could delay it."

In a decision issued Monday, Judge Lawrence E. Kahn approved the Brothertown tribe's request. He said part of his job in determining whether the Brothertown group is owed the land would be deciding if it were a legitimate tribe. The Brothertowns are not federally recognized.

He also cautioned that he is skeptical that the group can prove it has existed since the 1700's and added that even if he finds that it has, such decision would not constitute bestowing federal recognition. That authority, he said, rests with the U. S. Bureau of Indian Affairs.

The Brothertown group has expressed an interest in casino developments and one of its leaders, Maurice "Storm" Camplain of Norwich, said Wednesday the tribe is interested only in reclaiming land in New York.

The tribe has about 150 members and is growing through an aggressive membership drive.

The Oneidas of New York, Wisconsin, and Ontario, who are co-plaintiffs in the case, have said the Brothertown land is separate from theirs and should not be made part of their lawsuit." You may get more information on the web page of both newspapers.

We, the Council, feel we must do something legally to protect our rights at this particular time. Not to put in a claim for the land but for reimbursement for that land that is ours. This is proven by the 1788 Fort Schuyler Treaty, giving our tribe 6 square miles not part of the Oneida Lands that still stands and has never been changed and in addition our petition for federal recognition.

The Council is presently in contact with a couple of lawyers hoping we do not get into quicksand but to do what is right for our Tribe and members. Legally.

As we mentioned in our last newsletter, we may have to request funding from our members to help in our case. Will keep you informed and you will be hearing from us with a special letter if necessary. It is a shame that we are forced to take this step, but it is the right to do so.

Don't forget read the rest of the newsletter and will see you at the Walk-a-thon, picnic and golf events. Looking forward to meeting you all.

PROFILE ON BROTHERTOWN TRIBE TO AIR ON PBS

The Brothertown Indians have been selected to be profiled on the PBS-broadcast series. The Visionaries. An 8-10 minute documentary on the Brothertown Indians, their history and current efforts to secure federal acknowledgement will be featured on this series which is hosted by actor Sam Waterston and broadcast on over 150 stations nationwide. Brothertown tribal member and consultant Nark Baldwin will be assisting the series producers in raising money to produce the profile. If enough funding is secured, filming for the profile could begin during the Brothertown Indian Homecoming the weekend of October 20, 2001. As part of this effort, public presentations of the resulting video will be held in six cities across Wisconsin. These programs will include talks by Brothertown Indians who have been active in the tribe's historical preservation and federal acknowledgement efforts and by local historians familiar with Brothertown tribal history. After the profile is produced, the tribe will receive 100 VHS copies of the documentary to use in our educational outreach efforts. Once the profile is complete it will begin airing on PBS starting in May 2002. The series reaches an audience of 20 million people and the profile will continue to air on PBS over a two-year period. 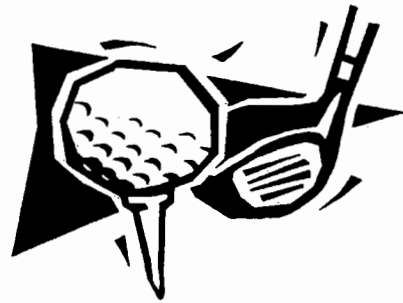

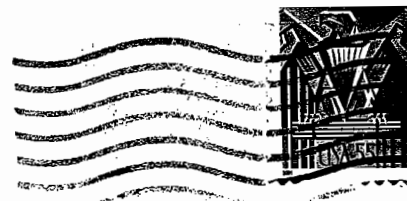

CHAIRPERSON'S CORNER

What a hot and wet summer we are having--but the tribe is still forging ahead despite the weather.

Gerry Johnson, Council Member, is on vacation in California but is going to Oregon, Washington and Idaho area. He will be trying to get some input towards amending our present constitution. Other regional meetings will be held where our membership is concentrated in Minnesota, Illinois and Wisconsin.

The present grant will help to defray some of the expenses incurred with these trips. We will compile all the input, work with the ideas given out, get copies to all head of household, if we have the correct address and then have a vote to accept or recind the ideas.

The Board of Commissioners looked into the purchase of land in Brothertown, part of the original reservation Lot #11. Which is being made available to us. There are 40 acres available for an asking price of \$494,00.00. This includes 300 ft Lake Winnebago frontage with road frontage of 5 acres abutting lakeshore drive with a home, barn and 2 sheds. The purchase of land will assist us in our recognition process.

This is where we need everyone's financial help. We have to depend upon our members. The Council suggested \$35.00 per year, per member over 18 years of age and we are very serious about asking for your financial help. Along with that suggestion the council wants to be able to mail each household a quarterly report four times a year. We need all the help we can get if you are serious about becoming recognized as an Indian Tribe.

The \$35.00 would help defray some of the expense of having 4 quarterly newsletters and the balance to be added to the land fund. The 40 acres would be used for a tribal office, a tribal museum and part of the land be kept natural. This will have to be studied further, such as getting a loan, what taxes would be, and zoning laws. A committee would be formed to keep track of the transactions for who has paid, not paid, payment to be made toward the loan taxes, etc. The committee would also notify those who are delinquent in paying.

During the meeting held in Gresham, WI seven member donated the required \$35.00. As you can see this is a HUGE project to undertake. Your cooperation and \$35.00 will be

greatly appreciated.

The Walk-a-Thon was held July 21st, the **HOTTEST** day of the year, and we had 30 brave souls who walked in the "Heritage Walk". When the walk was completed everyone went to the picnic at Calumet County Park. We had 80 in attendance there. Which was a fairly good turnout in spite of the heat. A great time was had by all. However it was somewhat disappointing due to the lack of small children. The Lambert Family, Picnic Committee had games planned for the children but only two were in attendance.

We need better participation in our annual events such as the Picnic, Homecoming and the Walk-a-Thon. We also planned a Golf outing for the following Sunday and had eight people participate. These events are planned to get together and to get better acquainted and to keep you up to date as to what is happening with your tribe. This is **YOUR** Indian tribe; we need participation and interest. Having the Walk-a-Thon collected \$2,800.00. This is to help with the expenses such as administration, keeping the office open and help with maintenance of the Union Cemetery in Brothertown. All for a good cause.

We are #4 on the Bureau of Administration and Resource in Washington, but waiting to be reviewed for recognition.

The Brothertown Indians of Wisconsin has a lawyer and have filed a letter and resolution with the Civil Court Judge in order to seek a claim for six square miles of land in New York that was presented to our tribe in 1788 Fort Schuyler Treaty and never taken away. We are not a part of the Oneida Land Claim at this time.

The higher financial aide of Wisconsin office is still assisting students attending Wisconsin Higher Education Schools. Scholarship forms must be completed and forwarded to the tribal chairperson. Please read further for committee reports, membership, crafts treasurers and a list of your council members and their address and phone numbers.

THE BROTHERTOWN INDIANS NEED YOUR SKILLS

All of your existing Committees are short of members. The current members' commitments of leadership, energy, time, and dedication are assuring that the heritage of the Brothertown Indians continues. But, they need help.

Today, volunteers are needed for established committees like Crafts, Heritage and Traditions, and Enrollment. We will also need participants for proposed committees such as Strategic Planning, Business Development, and an Editorial Committee responsible for this newsletter. Not one of these committees can either continue to exist as presently constituted, or even come into effect, without your active involvement.

Tomorrow, as Recognition becomes an actuality and not just a pursuit, we will need your skills in accounting, finance, computers, marketing, public relations, law, real estate, photography and many more fields of expertise that will help the Brothertown Indians flourish.

What will an active leadership role in Tribal matters mean to you? Any number of reasons from the practical – you'll learn new skills; to the philosophical – you'll be making a difference!

TRIBAL STATUS RECOGNITION PROCESS

In 1979 we filed our intent for Tribal Recognition with the Bureau of Indian Affairs. At the time we were ranked #67 on their waiting roster.

For the past three years we have been #4 on the list but recent developments have created uncertainty about the Recognition process itself. Earlier this year the Bush Administrations' selection to head the Bureau, Neal A. McCaleb, overturned preliminary recognition of two bands granted in the latter days of the Clinton Administration. As a result the status of the Nipmuc Nation of Massachusetts and the Duwamish Tribe of Washington remain in limbo.

Currently, you should all have in your possession a 'Preliminary Working Text' for your review as well as a cover letter from the Council noting the ratification time-line.
