THE FIRST BROTHERTOWN PEACEMAKERS

The act of March 4, 1796 set off the Brothertown tract on Oneida lands, into 149 lots and arrangements for town government. The governor and council were to appoint five Indians as "Keepers of the Peace," or "Peacemakers," who should hold office as long as the governor saw fit. They were to hold court on the first Monday of the month at Brothertown and hear and determine all disputes concerning debts and trespass where damage did not exceed 5 pounds and also all violations of town laws. Failure to pay fines was punishable to imprisonment of not more than 30 days. They were also commissioners of highway, which were to be four rods wide, with power to lay out and repair the same. The annual town meeting was to be held on the first Tuesday of April and all males that were 21 or over had the right to vote. They would elect a town clerk, two overseers of the poor, two marshals and as many overseers of highway as they deemed necessary. They could also choose fence viewers.

The white commissioners or superintendents of the Brothertown Indians were to determine what persons were entitled to rights, assign lots, advise as to the expenditure of income of invested funds, maintain a school, prevent the sale of intoxicating liquors and in general supervise their affairs. Joseph Kirkland was appointed attorney to defend their rights in court.

It was declared, "That it shall not be lawful by the authority of Brothertown that any woman shall be permitted to speak that has causes depending in the Brothertown courts without asking some particular question or she shall apply to some suitable man to speak in her behalf. They made stringent laws against immorality, profanity, drunkenness, theft, extortion, idleness, neglect of children, and marriages with persons of Negro blood. Women who were widows were to work on the roads or at any other public business, half as much as the men. Anyone elected to an office who declined to serve was fined two and a half dollars and those officers who neglected their duties were fined twice that amount.

They adopted the following town laws:

There shall be no traveling, servile laboring or working (works of necessity and charity ex-

cepted) shooting, fishing, sporting, playing, horseracing, hunting or any unlawful exercise or pastime, by any Person or Persons on the first day of the week commonly called Sunday.

If any person shall permit any playing with Cards or dice in his house, or bet win or lose any sum of money at such play and shall be thereof convicted, [he] shall forfeit and pay a sum not to exceed five Dollars or under fifty cents for every such offence, one half to the complainant and the other half to the People of Brothertown.

If any of said inhabitants shall Divulge any Report about any of said inhabitants either Male or Female, and shall not have sufficient proof to support what he, she or they hath Divulged and reported, then the Divulger or Divulgers shall pay a fine of ten shillings for every Breach of this bye-law if found so convicted.

If any of the inhabitants shall abuse any one of the aforesaid inhabitants in their Houses or at any other place either by foul language or assault, he or they shall be immediately summoned to be and appear before the Peacemakers of said town, then and there to be adjudged before them as the Case may by in their judgment to decide the matter, to be deemed just and equitable.

The first Peacemakers appointed to the Brothertown Court in 1796 were David Fowler, John Tuhie, John Skeesuck, Isaac Wauby and Samuel Scipio. The first three served until their death which occurred in 1807 and 1811 respectively. The first clerk was David Fowler, Jr.

Following is a copy of the first court meeting bearing a date. Several were held before but have no date. This is from the old court record book dating from 1797 to April 4, 1843.

Thomas Isaac's vs. Sarah Simon Personally served on the defendant

The said Thomas Isaac's produces his Complaint against the said Sarah Simon the said Sarah Simon personally appeared and made answer unto the complaint of said the Thomas Isaac's then said Sarah bought on the note that the said Thomas demanded of her, and after examining their accts. was then Due Twenty Eight shillings to be paid within Thirty days.

David Fowler Jun. Clk"

One of the most unusual sessions of the court was held Monday July 6, 1807 when Thomas Crosley appeared as plaintiff against Phebe Fowler, Charles Wimpey, Thomas Wint, James Sampson, Elizabeth Wimpey, Philenea Crosley and George Crosley for Breach of Sabbath. George Crosley was the Plaintiffs father and Philenea his wife. Each was assessed a fine of \$.75 and costs of \$.12 cents. We wonder whether people today would have intestinal fortitude enough to prosecute their own father and wife for the same act.

When the court convened on Monday Dec. 5, 1808 the chairs of the Peacemakers were filled with new faces. They were Thomas Dick, Sen. The Baptist Preacher who was to conduct the first services of that church in Wisconsin in 1834, Benjamin Garrett Fowler the Freewill Baptist Minister, John Johnson Jr., Isaac Wauby. They were the most prominent men in the town and all were deeply religious.

The last case heard before the Peacemakers Court was held Dec. 4 1837 at which a case for debt was tried with Ally Mossock, plaintiff and Charles Anthony, defendant. The Peacemakers found for the plaintiff and ordered the defendant to pay the sum of twenty dollars and cost of suit within 30 days.

The last entry in the old record book reads," In 1843 there was no courts held in the Brothertown tribe or nation of Indians in consequence of there being no process returned."

Dated Brothertown April 4th 1843

Jas. Wiggins Clerke"

After 46 years of service the Brothertown Court closed its books which were an outstanding

example of what could be accomplished by the American Indian. It is the only book of its kind that we know of to be extant and is unique in the history of the American Indians.

All manner of complaints were heard by the court, the most numerous being failure to work on the road, debt, breaking the Sabbath, assault and battery, and drunkenness. Others were trespass, false report abuse, stealing timber, vagrancy, slander, playing cards, setting dog on sheep, keeping a disorderly house, damaging the mill, and neglect of office to which they were elected.

Tribal Historic Preservation Officer (THPO)

Tribal Historic Preservation Officer (THPO) is a new tribal position approved by the Tribal Council at the October 28th council meeting This officer's responsibilities include identifying and maintaining inventories of culturally significant artifacts belonging to the Brothertown Nation, and conducting educational programs on the importance of preserving historic resources.

Preservation and protection of Native American historic resources, at least archeological resources, dates back to at least the Antiquities Act of 1906, usually seen as the first federal historic preservation law in the United States.

Courtney Cottrell, an anthropology student at UW-Madison will take over this position. and be the Tribal liaison for Mr. Cipolla. All artifacts will become the property of the Brothertown Nation after Mr. Cipolla is through with his research.

Election Procedure

If an absentee ballot is required, the procedure will be the following:

- Request must be made in writing to the Brothertown Office, P. O. Box 1165, Fond du Lac, WI, 54936 by tribal member(s). Only one request per envelope will be honored.
- Request for absentee ballot should be postmarked no later than 10 business days before the election.
- Election Committee will appoint member to pick up requests daily at the Post office.
- Validation of membership is verified, using list of all eligible voting members given to committee, both numerical and alphabetical.
- Once verified, specially addressed envelopes and ballots, which are initialed by all members of the Nominating Committee, will be sent out to the absentee voter via First Class USPS.
- Absentee ballot name, address, roll number, date ballot request received, date ballot sent out and date ballot received will be kept on a data base daily.
- Absentee ballots must be received in mail by close of business day prior to the Election Day and will be locked in a separate box which will be kept at the Brothertown Office in Fond du Lac. Key to this box will be kept with an impartial person until the day of election.
- Polling day ballots will be kept in a separate locked ballot box.
- Ballots cannot be destroyed for 30 calendar days after the election.

The election will be held at the Brothertown Office, 82 S. Macy Street, Fond du Lac, Wisconsin on Saturday, May 19, 2007 from 10:00 AM - 2:00 PM.

On the day of election, members of the Election Committee will check in and verify voting members.

Voting will close at 2:00 PM, at which time the ballot boxes will be opened and counted immediately in an open environment. Prior to counting the ballots the Election Committee must verify the appropriate number of ballots for the election.

The results of the election will be announced immediately after the count has been finalized.

ANTHROPOLOGIST SPECIAL GUEST AT FEBRUARY COUNCIL MEETING

Caroline Andler

Craig Cipolla was invited to attend the February 17th Council meeting to discuss his doing an Archaeological dig at historic Brothertown. For the last four years he worked as part of a collaborative research project between the Eastern Pequot Tribal Nation and an archaeologist from the University of Massachusetts Boston. The project focuses on the last 300 years of Eastern Pequot community history as told from archaeological materials preserved on their 200+ acre reservation in North Stonington, Connecticut. The project is collaborative in the sense that it blends archaeological and anthropological field methods with Eastern Pequot cultural sensitivities and tribal government prerogatives, and it has involved anthropology students working with tribal members on a daily basis.

He was interested in discussing the potential of a similar project with the Brothertown Indian Nation that might focus on potential archaeological materials on our 19th-century land at Brothertown with special focus on the harbor and the grist Mill and saw mill along the creek.

"In terms of project scope, I am interested in using archaeological materials (e.g. architectural debris, material culture, animal bones etc.) in conjunction with oral and textual histories from Brothertown. At the moment I do not have specific research questions in mind but my general interests lie in issues of colonial politics, social identity, material culture studies, and zooarchaeology.

I feel that the archaeology of Brothertown could be a life's work in and of itself; I am hoping that I might have the opportunity to initiate this work with the dissertation research I am proposing."

Craig Cipolla is currently pursuing a PhD. in anthropological archaeology at the University of Pennsylvania. He has a Bachelor's degree in anthropology and a Master's degree in historical archaeology—both from the University of Massachusetts Boston. His research predominantly focuses on colonialism in the Northeast and consists of work in Massachusetts, Connecticut, New York, and Rhode Island.

After hearing Mr. Cipolla's presentation, the Brothertown Indian Nation Council made the following resolution: The Brothertown Indian Nation Council fully supports the efforts of Mr. Craig Cipolla for the archeological dig.

Craig Cipolla is interested in hearing from any Brothertown member with questions about his project and especially those Elders who have any information about the old building sites in Brothertown. He is already busy writing a grant to fund part of the project this summer.

Prairie Fest at UW Fond du Lac

At one time, most of Fond du Lac County was covered by prairie -- native grasslands that were home to bison, prairie chickens, bobolinks and other wildlife. At the Gottfried Arboretum on the UW-Fond du Lac campus, a group of volunteers has reestablished the native plants that once grew on this site.

The project began in 1991, with the goal of representing the original plant communities of Wisconsin in a small arboretum. At present, volunteers have planted 37 acres of native prairie grasses and wildflowers, developed two wildlife ponds and planted 176 native trees and shrubs. Most of the wildflower seeds were collected from some of the last remaining original prairie sites in Fond du Lac County. Some of the common wildflowers include black eyed susans, milkweeds, asters, goldenrods and many kinds of native sunflowers.

Prairies were once the great grasslands of North America. The Great Plains once stretched as an unbroken sea of grass, from Wisconsin west to the foothills of the Rocky Mountains, and from southern Canada to Texas. In Wisconsin, we have sufficient moisture for forests to dominate, but prairies were maintained by frequent burning, natural lightning fires and those started by the Indians kept the forest back allowing prairie to persist. The Indians of Wisconsin used burns to manage the prairie in order to provide grazing for the buffalo, elk, and deer. Controlled burns are used today to control brush and invasive weeds.

The Indians called these prairies "was-skis-sink" which signifies "shining prairies". At the Gottfried Arboretum, volunteers are recreating what nature had provided in this area prior to the time of modern settlement. It is an effort to re-establish what has been lost from the land, to give nature a second chance and provide for the public a chance to see and understand the prairie ecosystem.

The Brothertown Indians were represented with a display booth where Christine Scheid set up a beautiful display of baskets she had done and old, traditional baskets the Algonquin Indians made for daily use from ash, birch bark and sweet grass. She demonstrated the art of weaving baskets and answered many questions from interested festival goers.

An interesting gourd display attracted many questions about the traditional use of gourds by our New England

ancestors. Displayed were gourds for traditional uses, a large gourd with a branch for a handle, to carry water up from the stream or lake; a dipper gourd for drinking, and a several rattle gourds. Caroline Andler demonstrated the use of pine needles to decorate a gourd and displayed many modern painted birdhouses, bird feeders, holiday decorations, and dream catchers, all using gourds and natural materials.

It is a fun filled day for the entire family to learn what the land looked like when our ancestors came here in the early 1800's, what plants and trees were growing, and what animals were here that no longer live in Wisconsin. If you would like to demonstrate a craft next year — beading, porcupine quilling, or?

In a separate ceremony on May 24, Wightman was recognized with the USAA Community Service Award.


Wightman was also recognized this year for the Habitat for Humanity Volunteer of the Year Award.
